## 6. Unfinished Business.

6.1. Operational Policy 5 - Students Services Policy - VP Admin (Ahmik VP ADMIN:

## Re introduce discussion:

Last SRC meeting, we introduced our plan to make some changes and amendments to our operational policy number 5 , regarding our student services policy. Specifically for academic assistance. Per in our policy regarding academic assistance only presents section one, that states the student union shall endeavor to aid and assist and encourage members of the union to educational experience by participating in academic field trips, conferences and research administered by the finance committee. The issue is that with the lack of clarity in this section is that it gives room for the executive team being bias or we do not have the where to determine whether the conference was, or academic field has academic purposes or any other purposes. During the summer our executive team came up with plans, as discussed in the last meeting of the SRC. It is pretty much adding a new section, one of the comments that you guys suggested is that instead of mentioning thesis supervisor to include professor to make it more inclusive rather than this is maybe just for honours students. Instead of requiring 15 Credit hours in the field of study, reduce it to 12 credit hours and make some definitions of what we mean as first year students, for first year students could be exempted in this case below of credit hours. We will need to come up with a definition of what are first years and what are upper years. To come up with what happens if the conference is related to something that the student is interested in pursuing after graduation but their major(s) or field of study in their undergrad is not necessarily related to that. The reason that this topic was tabled was to give you guys more time to think about this and to bring more suggestions. We do not need to come up with a motion for this at this SRC, this is another opportunity to discuss and to hear your comments and ideas and then next SRC we might begin with introducing a motion.

Chair: is there any discussion from the rest?

The Students' Representative Council Le Conseil Représentatif des Étudiants Students' Union of St. Thomas University, Inc.

VP Administration: I just wanted to open a question to everyone, do you think that based on these suggestions and feedback if if we introduce some changes to this subsection, for next SRC, will we be good to review? Or are there any other suggestions that you guys think we should consider or make some changes to this subsection?

Off Campus Rep Craib: I know I was the one who mentioned the credit hour issue last week, I am just thinking entering your second year traditionally defined by having completed 30 credit hours already, say you are in your first semester in political science stream, but you do not do a ton of political science in your first year you would only have nine credit hours maximum typically. I would almost argue that we should move it to nine credit hours instead of 12. If you have 9 hours already you most likely are showing a minor in that department.

VP Student Life: This policy, I wonder if we take into consideration those students that are currently enrolled, let's say you take nine credit hours in your first year and then your second year first semester you have two classes on that field, then you would get to the 12 credit hours in the deadline. I wonder if we take this into consideration if it would allow for it to be more flexible. For example, I know that there are other courses such as fine arts that count as one credit hour, but if we can take into consideration of the ones that you are currently enrolled, that complement the trip you are taking, I think it could work and that it would be fair. For example, trip in New York, if you took two classes in your first year then enrolled in a class that counts towards the trip, then you have a little more background.

President: I just want to come back to the definition of a first year if we should be defining it by credit hours or enrolment. What would you guys see fit for the definition of a first year. Should we take it from the definition of the university? I just want to see if anyone had any suggestions?

VP Administration: Perhaps instead of first year being in terms of credit hours, or that the time that someone has started. It should be the number of semesters that a student has gotten, for example: first year student that is only in their first or second semester or only started in the winter. The winter semester would be there first semester and the fall semester would be their second semester of their first year.

VP Student Life: I think the idea that Ahmik just brought up it would be the best definition for us to go with. Also, for the credit hours situation, to ensure that they have had the opportunity to take classes in the field of study for a period of an academic year. It is a little more accessible because people that cannot take more than three classes, having that space a bit longer I think it is fair.

VP Administration: If there isn't any other discussion, I will be working to make the right changes to this policy then to present again at the next SRC. If you come with any other feedback during these days just send me an email and I will take it into consideration.
